ORDINANCE 200 S. MICHIGAN LLC Acct. No. 428767 - 1 Permit No 1134577

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to 200 S MICHIGAN LLC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Vault(s) under the public right-of-way adjacent to its premises known as 200 S. Michigan Ave..

Said Vault(s) at S MICHIGAN AVE measure(s):

One (1) at one hundred five point nine two (105.92) feet in length, and fourteen point one seven (14.17) feet in width for a total of one thousand five hundred point eight nine (1500.89) square feet.

Said Vault(s) at E ADAMS ST measured-

One (1) at one hundred seventy-one point seven five (171.75) feet in length, and fifteen (15) feet in width for a total of two thousand five hundred seventy-six point two five (2576.25) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1134577 herein granted the sum of sixteen thousand four hundred sixty-five (\$16,465.00) per annum in advance

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
