ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown in Map No. 28-G in the area bounded by

A line 50-feet south of and parallel to West 116th Street; the public alley next east of and parallel to (Unimproved) South Green Street; the public alley next east of and parallel to West 116th Street; a line 345 feet south of and parallel to West 116th Street; and Unimproved South Green Street (to those of a M2-1 Light Industry District).

To those of a M2-1 Light Industry District

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
