# BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS-2 Residential Single-Unit District symbols and indications as shown on Map No. 5-M in the area bounded by

the alley next north of and parallel to West North Avenue; a line 63.92 feet east of and parallel to North Mobile Avenue; West North Avenue; and North Mobile Avenue.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


