LOADING ZONES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, Section 160, of the Municipal Code of Chicago, the following locations are hereby designated as Loading Zones for the distances specified, during the hours specified:

9	South Front Street (west side) from a point 75 feet north of East 115th Street to a point 30 feet north from a point and 130 feet to a point 70 feet north thereof; 15 Minute Standing Zone, Use Flashing Lights, All Times, All Days, Public Benefit [02018-7379]
27	1335 West Lake Street (south side) from a point 20 feet east of North Ada Street to a point 80 feet east thereof; 30 Minute Standing Zone, 5:00am to 10:00am, Monday through Friday, And Also, 175 North Ada Street (east side) from a point 30 feet south of West Lake Street to a point 60 feet south thereof, And Also from a point 125 feet south of West Lake Street to a point 45 feet south thereof; 30 Minute Standing Zone, 5:00am to 10:00pm, Monday through Friday, Public Benefit [02018-7808]
27	688 North Morgan Street (west side) from a point 20 feet south of North Milwaukee Avenue to a point 100 feet south thereof; No Parking Loading Zone, All Times, All Days [02018-7888]
