BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, of the Municipal Code of Chicago, the following locations are hereby designated as Traffic Lane - Tow Zones, between the limits and during the times specified, standing or parking of any vehicle shall be considered a definite hazard to the normal movement of traffic:

- WARD TOW ZONES:
- 42 North Kingsbury Street (west side) from West Grand Avenue to a point 150 feet north thereof; No Parking Tow Zone, 7:00am to 9:00am and 4:00pm to 6:00pm, Monday through Friday, Public Benefit [02018-7953]
- 44 North Sheffield Avenue (west side), from West Addison Street to the first driveway south thereof: No Standing, No Stopping, No Parking Tow Zone, All Times, All Days, 'Public Benefit [02018-6900]

North Franklin Street (east side); Amend Ordinance Passed 06/27/18, journal page 80192, which reads: North Franklin Street (east side) from West Ontario Street to the first alley north thereof; No Parking, No Standing, No Stopping, by Striking: first alley north & Inserting: West Erie Street in lieu thereof -- (18-02066025) [02018-5324]

WARD AMEND TOW ZONES CONT'D:
