BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.

Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the B3-1, Community Shopping District symbols as shown on Map No. 1-G in the area bounded by:

The alley next north of and parallel to West Ohio Street; a line 210 feet east of and parallel to North Ashland Avenue; West Ohio Street; and a line 185 feet east of and parallel to North Ashland Avenue.
