ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the C3-2, Commercial, Manufacturing and Employment District symbols shown on Map 1-G in the area generally bounded by:

West Wayman Street; North Green Street; West Fulton Market Street; and North Peoria Street

to the designation of DS-3, Downtown Service District.

SECTION 2. This ordinance takes effect after its passage and approval.

In compliance with the notice requirements of Section 17-13-0107 of the Chicago Zoning Ordinance, please be informed that on or about October 31, 2018 an application for an Amendment to the Chicago Zoning Ordinance will be filed on behalf of the Applicant, 832 West Fulton LLC. for the property commonly known as 832 West Fulton Market Street.

The application seeks a change in zoning from C3-2, Commercial, Manufacturing and Employment District, to the designation of DS-3, Downtown Service District. The development site currently consists of a commercial building which is used for various restaurants, retail, and office space. There are approximately 60 on-site parking spaces. The Applicant is requesting a zoning amendment in order to increase the floor area ratio from 2.2 to 3.0, in order to add some minor enclosures on the roof and interior of the building. The height of the building is approximately 50 feet and will not change. In addition, the DS-3 District will facilitate business licensing for existing businesses.






