MOUNT CARMEL HIGH SCHOOL Acct. No
301741 - 1 Permit No. 1136568

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to MOUNT CARMEL HIGH SCHOOL, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use one (1) Occupation of Space (Bleachers with auxiliary access) on the public right-of-way adjacent to its premises known as 1426-48 E. 65th St..

Said Occupation of Space (Bleachers with auxiliary access) at E. 65th measure(s):
One (1) at two hundred eighty (280) feet in length, and fourteen point five (14 5) feet in width for a total of four thousand sixty (4060) square feet

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development, Department of Transportation (Division of Project Development), and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1136568 herein granted the sum of one thousand four hundred fifty-eight (\$1,458 00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) yearafrom and after Date of Passage.
