ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.

Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the BI-1, Neighborhood Shopping District symbols as shown on Map No. 7-K in the area bounded by:

A line 249.27 feet south of and parallel to West Barry Avenue; the alley next east of and parallel to North Cicero Avenue; a line 474.27 feet south of and parallel to West Barry Avenue; North Cicero Avenue.

To those of a C1-1, Neighborhood Commercial District

SECTION 2. This Ordinance takes effect after its passage and due publication.
