SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 5-J in the area bounded by

The alley next north of and parallel to West Wabansia Avenue; a line 74.5 feet west of and parallel to North Sawyer Avenue; West Wabansia Avenue; and a line 99.5 feet west of and parallel to North Sawyer Avenue,

to those of a RT4 Residential Two-Flat, Townhouse and Multi-Unit District and a corresponding uses
