ORDINANCE

Archer Building Lofts Condominium Association Acct.
No. 335777 -1 Permit No. 1136837

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to Archer Building Lofts Condominium Association, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, fifty-two (52) Balcony(s) projecting over the public right-of-way adjacent to its premises known as 2310 S. Canal St..

Said Balcony(s) at S Canal St measure(s):

Twenty-four (24) at eight point nine two (8.92) feet in length, and five (5) feet in width for a total of one thousand seventy point four (1070.4) square feet.

Said Balcony(s) at S Archer Ave measure(s):

Twenty-eight (28) at eight point nine two (8.92) feet in length, and five (5) feet in width for a total of one thousand two hundred forty-eight point eight (1248.8) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1136837 herein granted the sum of three thousand nine hundred (\$3,900.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage-feteqation or replacement costs

associated with damage, relocation or removal of private property caused by the City performing work in the public way.
