ORDINANCE SUPER FAIR FOODS Acct. No. 9535 -1 Permit

No. 1136277

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to SUPER FAIR FOODS, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, three (3) Fire Shutter(s) projecting over the public right-of-way adjacent to its premises known as 6319 S. Vernon Ave..

Said Fire Shutter(s) at S Vernon Ave measure(s):

One (1) at four point eight three (4.83) feet in length, and two point one seven (2.17) feet in width fora total often point four eight (10.48) square feet.

One (1) at twenty-two point four two (22.42) feet in length, and two point five (2.5) feet in width for a total of fifty-six point zero five (56.05) square feet.

One (1) at nine point one seven (9.17) feet in length, and two point five (2.5) feet in width for a total of twenty-two point nine three (22.93) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1136277 herein granted the sum of one thousand two hundred (\$1,200.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs
