EXTRA SPACE STORAGE Acct. No. 299487 - 2 Permit No. 1137222

Be It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to EXTRA SPACE STORAGE, upon the terms and subject to the conditions of this ordinance to maintain and use two (2) sign(s) projecting over the public right-of-way attached to its premises known as 2100 W. Fullerton Ave..

Said sign structure(s) measures as follows; along W. Fullerton:

One (1) at forty-two point five (42.5) feet in length, four (4) feet in height and thirty-two (32) feet above grade level.

One (1) at forty point four one (40.41) feet in length, four (4) feet in height and thirty-two (32) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1137222 herein granted the sum of six hundred (\$600.00) per annum in advance.
