ORDINANCE THE VEGGIE GRILL INC Acct.

No. 422130-3 Permit No. 1135513

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to THE VEGGIE GRILL INC, upon the terms and subject to the conditions of this ordinance to maintain and use two (2) sign(s) projecting over the public right-of-way attached to its premises known as 629 N. Wells St..

Said sign structure(s) measures as follows; along N. Wells Street:

One (1) at two point five (2.5) feet in length, two point five (2.5) feet in height and fourteen point one seven (14.17) feet above grade level.

Said sign structure(s) measures as follows; along E. Ontario Street:

One (1) at two point five (2.5) feet in length, two point five (2.5) feet in height and fourteen point one seven (14.17) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1135513 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.

The permit holder agrees to hold the City of Chicago harmless for any associated with damage, relocation or removal of private property caused by	damage, relocation or replacement costs the City performing work in the public way.
