### Memorial Resolution for Sam Carter Jr.

WHEREAS, Sam was known for his heart of gold and always went out of his way to be kind and helpful to people. He was a "jack of all trades", a very sociable person, and said to be quite dapper in his appearance. Sam was also a loyal Precinct Captain for the 38<sup>th</sup> precinct for many years. He enjoyed working with the residents and he continued to remain active in the community; and

WHEREAS, Sam leaves to cherish his memory, his adoring wife Brenda, his loving daughter, Samika and three wonderful grandchildren, James, Destiny and Dealeon, along with his extended family and treasured friends; and

WHEREAS, A devoted family man and a man of faith, Sam joined Macedonia Tabernacle Baptist Church in 1968 under the leadership of Reverend Jackson. Sam became a deacon and spent much of his time nurturing the spiritual needs of the congregation. He was also very involved as a member of the choir, and also shared his spirit through voice, as a lead singer; and

WHEREAS, In 1979, Sam joined True Vine of Holiness Baptist Church where Bishop Henderson Hill is leader and overseer. Sam was an active and faithful member until he made his transition on January 1, 2019; and
