### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the current CI -2 Neighborhood Commercial District symbols and indications as shown on Map No. 4-F in the area bounded by:

the public alley next north of and parallel to West 18<sup>th</sup> Street; a line 48 feet west of and parallel to South Clinton Street; West 18<sup>th</sup> Street; and a line 72 feet west of and parallel to South Clinton Street

to those of a B2-3 Neighborhood Mixed-Use District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.


