ORDINANCE

WHEREAS, the City of Chicago ("City") is a home rule unit of government by virtue of the provisions of the Constitution of the State of Illinois of 1970, and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, pursuant to ordinance ("Vacation Ordinance") adopted by the City Council of the City of Chicago (the "City Council"), on October 31, 1984, and published in the Journal of the Proceedings of the City Council (the "Journal") for such date at pages 10677 through 10679, the City Council approved the vacation of a portion of that certain alley and a portion of West Carroll Avenue, each as legally described in Section 1 of the Vacation Ordinance, to LaSalle National Bank, as trustee of trust number 104102 ("Trustee 104102"); and

WHEREAS, such vacation was conditioned, in part, on Trustee 104102, or its successors or assigns, recording: (a) a grant of easement for a strip of land 24 feet in width over, upon and across the right of way of Carroll Avenue as vacated in the Vacation Ordinance, to remain open above the existing grade (at track level) and below an elevation of 18 feet above the existing grade for (i) public ingress and egress, (ii) installation, maintenance, removal and operation of public water and sewer lines, and (iii) installation, maintenance, removal, and operation of railroad tracks by the Chicago and North Western Transportation Company, its successors and assigns; and (b) a grant of easement to the City for pedestrian ingress and egress, over, upon and across an area of not less than 25,000 square feet in the aggregate, both along the Chicago River and above the improvements to be constructed over a to-be-established vehicular ingress and egress easement; and

WHEREAS, Trustee 104012 subsequently caused a portion of West Carroll Street vacated by the Vacation Ordinance to be conveyed to LaSalle National Bank, as trustee, pursuant to trust no. 109495 ("Trustee 109495") (Trustee 104102 and Trustee 109495, together, the "Original Owners"); and

WHEREAS, pursuant to that certain "Grant of Easements" dated April 24, 1985, and recorded on June 10, 1985 with the Office of the Recorder of Deeds of Cook County, Illinois (the "Recorder's Office"), as document number 85054196, the Original Owners granted the City a vehicular ingress and egress easement

in accordance with the Vacation Ordinance, over and across a portion of the "Site" legally described in Exhibit A attached hereto and incorporated herein (the "Vehicular Ingress and Egress Easement"); and

WHEREAS, pursuant to that certain "Grant of Easements for Pedestrian Ingress and Egress" ("Original Agreement") dated April 24, 1985, and recorded on June 10, 1985, with the Recorder's Office, as document number 85054195, the Original Owners granted the City, in accordance with the Vacation Ordinance, certain non-exclusive easements for pedestrian ingress and egress over and across a portion of the Site (the "Pedestrian Ingress and Egress Easement"); and

WHEREAS, pursuant to that certain "First Amendment to Grant of Easements for Pedestrian Ingress and Egress" ("First Amendment") (the Original Agreement, as amended by the First Amendment, the "First Revised Agreement") dated January 14, 1986, and recorded on April 7, 1986, with the Recorder's Office as document number 86131769, entered into by and among the City, LaSalle National Bank, as trustee, pursuant to trust no. 110339 ("Trust 110339"), as the successor in interest to Trust 104102, and Trust 109495, the parties to the First Amendment, among other things, approved new drawings that superseded the drawings

attached to the Original Agreement as Exhibit C; and

WHEREAS, such new drawings included a revised Pedestrian Ingress and Egress Easement and a vehicular and pedestrian easement (the Pedestrian Ingress and Egress Easement, as amended by the First Amendment, together with the vehicular and pedestrian easement established in Section 2 of the First Amendment, collectively, the "Existing Easements", which are depicted in Exhibit B attached hereto); and

WHEREAS, 321 North Clark Property, LLC, a Delaware limited liability company ("Current West Sub-Parcel Owner"), warrants and represents that it owns the west approximately 134.18 feet of the Site (the "West Sub-Parcel"); and

WHEREAS, Current West Sub-Parcel Owner desires to relocate a portion of the Existing Easements located at the Plaza Level and at the River Front Level of the West Sub-Parcel; and

WHEREAS, the contemplated revision to the Existing Easements would allow for the new creation of ADA accessibility, additional commercial development, and would bring the public into closer proximity to the Chicago River; and

WHEREAS, upon due investigation and consideration by the City's Department of Transportation, the Commissioner of the Department of Transportation (the "Commissioner") has determined that the public interest now warrants the relocation of the Existing Easements; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The foregoing recitals are hereby adopted as the findings of the City Council.

SECTION 2. The Commissioner or a designee of the Commissioner is each hereby authorized, with the approval of the City's Corporation Counsel as to form and legality, to enter into a Second Amendment to Grant of Easements for Pedestrian Ingress and Egress ("Second Amendment to Grant of Easements") in substantially the form attached hereto as Exhibit C. and to negotiate, execute and deliver such other supporting documents as may be necessary or appropriate to carry out and comply with the provisions of the Second Amendment to Grant of Easements, with such changes, deletions and insertions as shall be approved by the persons executing the Second Amendment to Grant of Easements.

SECTION 3. If any provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such provision shall not affect any of the other provisions of this ordinance.

SECTION 4. All ordinances, resolutions, motions or orders in conflict with this ordinance are hereby repealed to the extent of such conflict.

SECTION 5. This ordinance shall take effect immediately upon its passage and publication.

AND THE FOLLOWING: PARCEL 1:

Lots 1, 2, and 3 in Assessor's Division of Lot 1 in Block 2 in Original Town of Chicago in Section 9, Township 39 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois.

PARCEL 2:

Lots 2, 3 and 4 (except the northerly 31 feet thereof) in Block 2 in the Original Town of Chicago in Section 9, Township 39 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois, said premises being otherwise described and bounded as follows: Beginning at a point where the east line of North Clark Street intersects the south line of New North Water Street in the City of Chicago, Cook County, Illinois; thence running east along said south line of said New North water Street, 240 feet, more or less, to the east line of Lot 2 in Block 2 in Original Town of Chicago aforesaid; thence south along said east line of said Lot 2 to the Chicago River; thence west along and following the north line of said river, 240 feet, more or less, to the point where said north line of said river intersects the east line of said North Clark Street; thence north along the east line of said North Clark Street to the point of beginning (except the northerly 31 feet thereof).

**SECOND AMENDMENT TO GRANT OF
EASEMENTS FOR PEDESTRIAN INGRESS
AND EGRESS**

THIS SECOND AMENDMENT TO GRANT OF EASEMENTS FOR PEDESTRIAN INGRESS AND EGRESS (this "Second Amendment") is made on or as of this _____ day of _____, 20____ by and between 321 NORTH CLARK PROPERTY LLC, a Delaware limited liability company ("Current West Sub-Parcel Owner"), and the City of Chicago, an Illinois municipal corporation and home rule unit of local government (the "City"). Capitalized terms used in this Second Amendment but not defined herein shall have the meaning set forth in the "Original Agreement," as amended by the "First Amendment" (as those two terms are defined below).

BACKGROUND

WHEREAS, pursuant to ordinance ("Vacation Ordinance") adopted by the City Council of the City of Chicago (the "City Council"), on October 31, 1984, and published in the Journal of the Proceedings of the City Council (the "Journal") for such date at pages 10677 through 10679, the City Council approved the vacation of a portion of that certain alley and a portion of West Carroll Avenue, each as legally described in Section 1 of the Vacation Ordinance, to LaSalle National Bank, as trustee of trust number 104102 ("Trustee 104102"); and

WHEREAS, such vacation was conditioned, in part, on Trustee 104102, or its successors or assigns, recording: (a) a grant of easement for a strip of land 24 feet in width over, upon and across the right of way of Carroll Avenue as vacated in the Vacation Ordinance, to remain open above the existing grade (at track level) and below an elevation of 18 feet above the existing grade for (i) public ingress and egress, (ii) installation, maintenance, removal and operation of public water and sewer lines, and (iii) installation, maintenance, removal, and operation of railroad tracks by the Chicago and North Western Transportation Company, its successors and assigns; and (b) a grant of easement to the City for pedestrian ingress and egress, over, upon and across an area of not less than 25,000 square feet in the aggregate, both along the Chicago River and above the improvements to be constructed over a to-be-established vehicular ingress and egress easement; and

WHEREAS, pursuant to that certain "Grant of Easements" dated April 24, 1985, and recorded on June 10, 1985 with the Office of the Recorder of Deeds of Cook County, Illinois (the "Recorder's Office"), as document number 85054196, the Original Owners granted the City a vehicular ingress and egress easement in accordance with the Vacation Ordinance, over and across a portion of the "Site" legally described in Exhibit 1 attached hereto and incorporated herein (the "Vehicular Ingress and Egress Easement"); and

WHEREAS, pursuant to that certain "Grant of Easements for Pedestrian Ingress and Egress" ("Original Agreement") dated April 24, 1985, and recorded on June 10, 1985, with the Recorder's Office, as document number 85054195, the Original Owners granted the City, in accordance with the Vacation Ordinance, certain non-exclusive easements for pedestrian ingress and egress over and across a portion of the Site (the "Pedestrian Ingress and Egress Easement"); and

WHEREAS, pursuant to that certain "First Amendment to Grant of Easements for Pedestrian Ingress and Egress" ("First Amendment") (the Original Agreement, as amended by the First Amendment, the "First Revised Agreement") dated January 14, 1986, and recorded on April 7, 1986, with the Recorder's Office as document number 86131769, entered into by and among the City, LaSalle National Bank, as trustee, pursuant to trust no. 110339 ("Trust 110339"), as the successor in interest to Trust 104102, and Trust 109495, the parties to the First Amendment, among other things, approved new drawings that superseded the drawings attached to the Original Agreement as Exhibit C; and

WHEREAS, such new drawings included a revised Pedestrian Ingress and Egress Easement and a vehicular and pedestrian easement (the Pedestrian Ingress and Egress Easement, as amended by the First Amendment, together with the vehicular and pedestrian easement established in Section 2 of the First Amendment, collectively, the "Existing Easements", which are depicted in Exhibit 2 attached hereto); and

WHEREAS, the First Amendment also included a Kinzie Street level public access easement, as depicted on Exhibit 3 attached hereto (the "Kinzie Easement"); and

WHEREAS, Current West Sub-Parcel Owner warrants and represents that it owns the west approximately 134.18 feet of the Site, as legally described and depicted in Exhibit 4 attached hereto (the "West Sub-Parcel"); and

WHEREAS, Current West Sub-Parcel Owner desires to relocate a portion of the Existing Easements located at the Plaza Level and at the River Front Level of the West Sub-Parcel; and

WHEREAS, the contemplated revision to the Existing Easements would allow for the new creation of ADA accessibility, additional commercial development, and would bring the public into closer proximity to the Chicago River; and

WHEREAS, upon due investigation and consideration by the City's Department of Transportation, the Commissioner of the Department of Transportation has determined that the public interest now warrants the relocation of the such portions of the Existing Easements as described in this Second Amendment; and

WHEREAS, this Second Amendment does not amend, supersede or revise in any respect the

Vehicular Ingress and Egress Easement or the Kinzie Easement; and

WHEREAS, this Second Amendment does not amend, alter or supersede any portion of the Existing Easements that are not located on the West Sub-Parcel;

NOW, THEREFORE, in consideration of the above recitals, the mutual covenants herein contained, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. INCORPORATION. The foregoing recitals constitute an integral part of this Second Amendment and are incorporated herein by this reference with the same force and effect as if set forth herein as agreements of the parties.

2. RELOCATION OF EXISTING EASEMENTS. The plaza level and the river front level portions of the Existing Easements on the West Sub-Parcel are each hereby relocated to the locations identified in Exhibit 5 and Exhibit 6, respectively, attached hereto.

3. RELEASE. Those certain sections of the Pedestrian Ingress and Egress Easement at the plaza level and at the river front level, as identified in Exhibit 7 and Exhibit 8 attached hereto, respectively, as being released are hereby released from the First Revised Agreement and this Second Amendment.

4. AUTHORITY. Current West Sub-Parcel Owner represents that it is a Delaware limited liability company duly organized, validly existing, and in good standing under the laws of the State of Delaware, and validly existing and in good standing under the laws of the State of Illinois, with full power and authority to enter into this Second Amendment, and the person signing this Second Amendment on behalf of the Current West Sub-Parcel Owner has the authority to do so. The City's execution of this Second Amendment is authorized by ordinance ("Second Amendment Ordinance") passed by the City Council on _____, 20____, and published in the Journal for such date at pages _____ through _____. A copy of the Second Amendment Ordinance is attached hereto as Exhibit 9.

5. RECORDING. Current West Sub-Parcel Owner shall pay to record this Second Amendment and other documents incidental thereto.

6. EXHIBITS. All exhibits referred to herein and attached hereto shall be deemed part of this Second Amendment.

7. FULL FORCE AND EFFECT. Except as amended hereby, the First Revised Agreement shall continue in full force and effect as the binding obligations of the City, Current West Sub-Parcel Owner, and any owner of all or any portion of the Site, and their successors and assigns.

8. COUNTERPARTS. This Second Amendment may be executed in any number of counterparts, each of which shall be deemed an original and all of which, taken together, shall constitute a single, integrated instrument.
