ORDINANCE

NORTH SHORE FOOD & LIQUOR Acct. No.

366607 -1 Permit No. 1138252

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to NORTH SHORE FOOD & LIQUOR, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, four (4) Awning(s) projecting over the public right-of-way adjacent to its premises known as 6701-6703 N. Clark St..

Said Awning(s) at Clark measure(s):

One (1) at sixteen (16) feet in length, and three (3) feet in width for a total of forty-eight (48) square feet. Said

Awning(s) at Clark & Northshore measure(s):

One (1) at six (6) feet in length, and three (3) feet in width for a total of eighteen (18) square feet. Said

Awning(s) at Northshore measure(s):

One (1) at twenty-eight (28) feet in length, and three (3) feet in width for a total of eighty-four (84) square feet. One (1) at twenty (20) feet in length, and three (3) feet in width for a total of sixty (60) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1138252 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.
