ORDINANCE
RUSH UNIVERSITY MEDICAL CENTER Acct. No.
62954 - 2 Permit No. 1137628

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to RUSH UNIVERSITY MEDICAL CENTER, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use six (6) Pipe(s) under the public right-of-way adjacent to its premises known as 1653 W. Congress Pkwy..

Said Pipe(s) at S. Ashland Avenue measure(s):

One (1) at one hundred fifty-four (154) feet in length, and four (4) feet in width for a total of six hundred sixteen (616) square feet. Said pipe shall be approximately twenty-two (22) feet in depth.

One (1) at one hundred fourteen (114) feet in length, and three point five (3.5) feet in width for a total of three hundred ninety-nine (399) square feet. Said pipe shall be approximately twenty-two (22) feet in in depth.

One (1) at one hundred ten (110) feet in length, and two point five (2.5) feet in width for a total of two hundred seventy-five (275) square feet. Said pipe shall be approximately twenty-two (22) feet in depth.

One (1) at one hundred fifty-four (154) feet in length, and two point five (2.5) feet in width for a total of three hundred eighty-five (385) square feet. Said pipe shall be approximately sixteen (16) feet in depth.

One (1) at one hundred fourteen (114) feet in length, and two (2) feet in width for a total of two hundred twenty-eight (228) square feet. Said pipe shall be approximately sixteen (16) feet in depth.

One (1) at one hundred ten (110) feet in length, and two point five (2.5) feet in width for a total of two hundred seventy-five (275) square feet. Said pipe shall be approximately sixteen (16) feet in depth.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of

Transportation (Office of Underground Coordination) and Department of Water Management.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1137628 herein granted the sum of two thousand four hundred (\$2,400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.
