A line 224.18 feet South of and parallel to West Roscoe Street; North Ridgeway Avenue; a line 261.68 feet South of and parallel to West Roscoe Street; the public alley next West of and parallel to North Ridgeway Avenue.

To those of an RT4, Residential Two-Flat, Townhouse and Multi-Unit District
