ORDINANCE

BE IT ORDAINED B Y THE CITY COUNCIL OF THE CITY OF CHICA GO:

SECTION I. Title 17 of the Municipal Code, the Chicago Zoning Ordinance, be amended by changing all the RSI Residential Single-Unit (Detached House) District and B2-3 Neighborhood Mixed-Use District symbols and indications as shown on Map No. 10-F in the area bounded by

a line 213.9 feet north of and parallel to West 43rd Street; the alley • next east of and parallel to South Halsted Street; West 43rd Street; and South Halsted Street,

to those of a B2-3 Neighborhood Mixed-Use District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
