ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-2, Residential Single-Unit, (Detached House) District symbols and indications as shown on Map NO. 9-M in the area bounded by

West Melrose Avenue; a line 121.77 feet west of and parallel to North Mobile Avenue; The Alley Next South of and parallel to West Melrose Avenue; and a line 151.77 feet west of and parallel to North Mobile Avenue

to those of a RT3.5 Residential Two-Flat, Townhouse and Multi-Unit District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.
