Section 17-8-0400 of the Chicago Zoning Ordinance, the Property, at the time applications for

amendments, modifications or changes (administrative, legislative or otherwise) to this Planned

Development are made, shall be under single ownership or under single designated control. Single

designated control is defined in Sec. 17-8-0400 of the Zoning Ordinance.

3. All applicable official reviews, approvals or permits are required to be obtained by the Applicant or its





On November 21, 2019, the Chicago Plan Commission recommended approval of a proposed amendment to Institutional Planned Development No. 50 submitted by Advocate North Side Health Network. The applicant proposed to rezone the subject property from B3-2 (Community Shopping District) to Institutional Planned Development 50, as amended, to construct a 74 ft. tall accessory parking garage with 408 parking spaces and ground floor clinic space. The planned development boundaries will be amended to accommodate the proposed parking garage (Subarea D) and the Chicago Transit Authority's right-of-way (Subarea E).
