ORDINANCE
NORTHWESTERN UNIVERSITY SETTLEMENT ASSOCIATION Acct. No.
26525 - 1 Permit No. 1140740

Se It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to NORTHWESTERN UNIVERSITY SETTLEMENT ASSOCIATION, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Bridge(s) projecting over the public right-of-way adjacent to its premises known as 1400 W. Augusta Blvd..

Existing bridge connect the buildings located at 1400 West Augusta Boulevard and 1012 North Noble Street. Existing bridge shall be a minimum of fourteen (14) feet, six (6) inches above grade level at its lowest point. Existing bridge is two (2) story in height, connecting the second (2nd) and third (3rd) floors of the buildings. Existing bridge measure sixty-eight (68) feet in length and span the sixteen (16) foot east/west public alley between buildings.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1140740 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

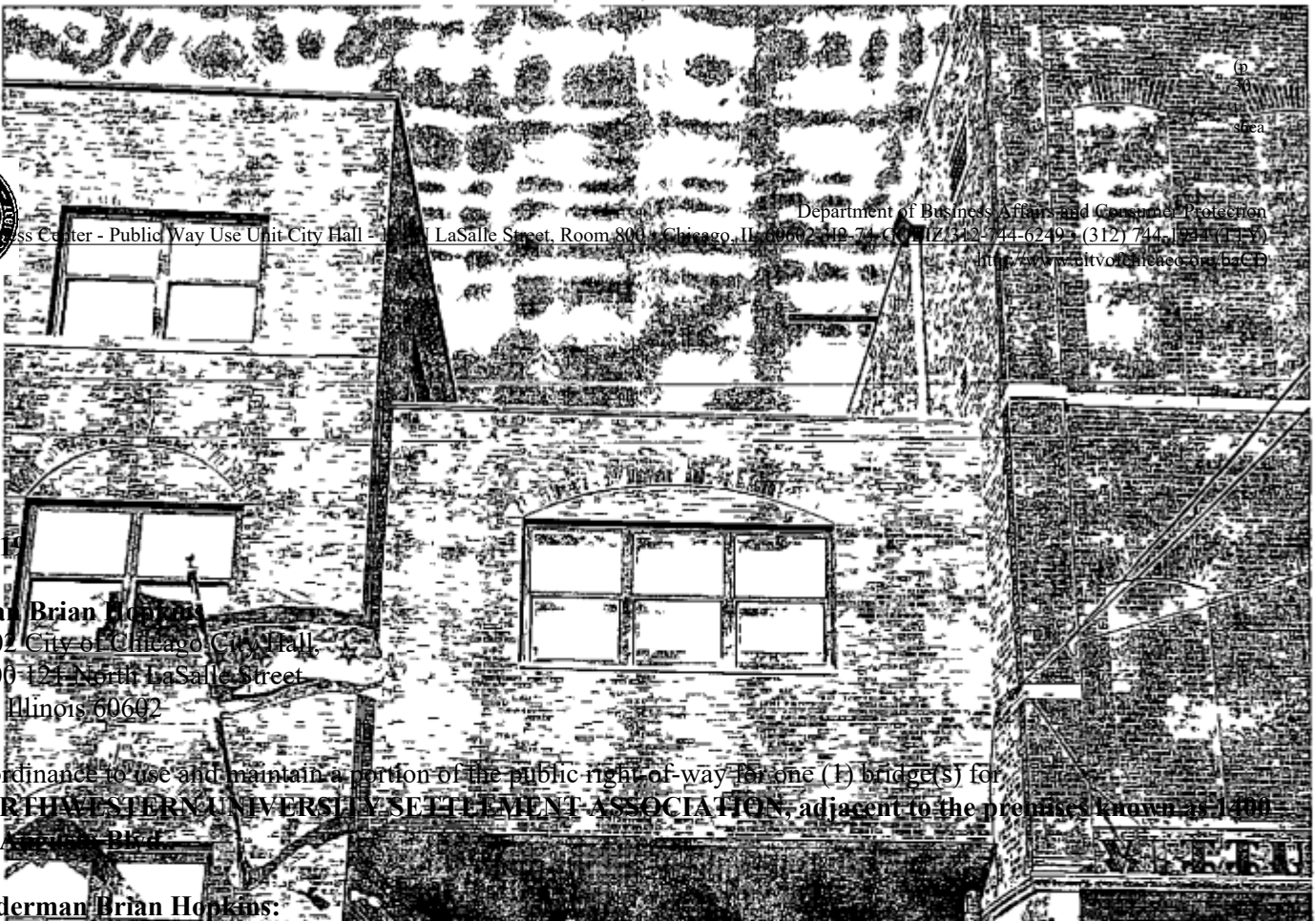
