### Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to 1528-32 N. PAULINA CONDO ASSOCIATION, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, seven (7) Fence (s) decorative iron fences to go around seven (7) existing planters on the public right-of-way for beautification purposes adjacent to its premises known as 1528-32 N. Paulina St..

### Said Fence(s) at N. PAULINA measure(s):

Four (4) at nine point six six (9.66) feet in length, and one (1) foot in width for a total of thirty-eight point six four (38.64) square feet.

#### Said Fence(s) at W. Pierce St. measure(s):

Three (3) at nine point six six (9.66) feet in length, and one (1) foot in width for a total of twenty-eight point nine eight (28.98) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1140528 herein granted the sum of zero (\$.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
