RUSH UNIVERSITY MEDICAL CENTER Acct. No.

62954 - 31 Permit No. 1139084

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to RUSH UNIVERSITY MEDICAL CENTER, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use sixty-four (64) Tieback System(s) under the public right-of-way adjacent to its premises known as 1520 W. Harrison St..

Said Tieback System(s) at 501-511 S Ashland measure(s):

Five (5) at forty-four (44) feet in length, and point five (.5) feet in width for a total of one hundred ten (110) square feet. Five (5) at thirty-nine (39) feet in length, and point five (.5) feet in width for a total of ninety-seven point five (97.5) square feet

Said Tieback System(s) at 513-523 S Ashland measure(s):

Eleven (11) at fifty-six (56) feet in length, and point five (.5) feet in width for a total of three hundred eight (308) square feet.

Eleven (11) at fifty-one (51) feet in length, and point five (.5) feet in width fora total of two hundred eighty point five (280.5) square feet.

Said Tieback System(s) at 525-527 S Ashland measure(s):

Four (4) at seventy-four (74) feet in length, and point five (.5) feet in width for a total of one hundred forty-eight (148) square feet.

Four (4) at sixty-nine (69) feet in length, and point five (.5) feet in width for a total of one hundred thirty-eight (138) square feet.

Said Tieback System(s) at 1550-1554 W Harrison measure(s):

Five (5) at seventy-six (76) feet in length, and point five (.5) feet in width for a total of one hundred ninety (190) square feet.

Five (5) at "seventy-one (71) feet in length, and point five (.5) feet in width for a total of one hundred seventy-seven point five (177.5) square feet.

Said Tieback System(s) at 1542-1548 W Harrison measure(s):

Six (6) at sixty-seven (67) feet in length, and point five (.5) feet in width for a total of two hundred one (201) square feet. Six (6) at sixty-two (62) feet in length, and point five (.5) feet in width for a total of one hundred eighty-six (186) square feet.

Said Tieback System(s) at 523 S Ashland measure(s):

One (1) at sixty-four (64) feet in length, and point five (.5) feet in width for a total of thirty-two (32) square feet. One (1) at fifty-eight (58) feet in length, and point five (.5) feet in width for a total of twenty-nine (29) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1139084 herein granted the sum of four hundred ten (\$410.00) per annum in advance.

Page 1

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way. Page 2
