ORDINANCE
UNIVERSITY OF CHICAGO Acct. No.
63878 - 66 Permit No. 1140729

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to UNIVERSITY OF CHICAGO, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Tieback System(s) under the public right-of-way adjacent to' its premises known as 1100 E. 57th St..

Said Tieback System(s) at E. 57th St & S. Ellis measure(s):

One (1) at two hundred forty (240) feet in length, and one hundred twenty (120) feet in width for a total of twenty-eight thousand eight hundred (28800) square feet. Existing Tieback System is approximately fifty-five (55) feet below grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1140729 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

Authority herein given and granted for a period of five (5) years from and after 11/05/2018,

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way. ,
