ORDINANCE  
UNIVERSITY OF CHICAGO MEDICAL CENTER Acct. No.  
6533- 14 Permit No. 1140781

*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to UNIVERSITY OF CHICAGO MEDICAL CENTER, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, three (3) Sheeting(s) under the public right-of-way adjacent to its premises known as 5700 S. Maryland Ave..

Said Sheeting(s) at S. Drexel Avenue measure(s):

One (1) at one hundred eighty-seven point eight three (187.83) feet in length, and one (1) foot in width for a total of one hundred eighty-seven point eight three (187.83) square feet. Existing sheeting is approximately twenty-five (25) feet in depth.

Said Sheeting(s) at E. 57th Street measure(s):

One (1) at five hundred seventy-six point two five (576.25) feet in length, and one (1) foot in width for a total of five hundred seventy-six point two five (576.25) square feet. Existing sheeting is approximately twenty-five (25) feet in depth.

Said Sheeting(s) at S. Cottage Grove Avenue measure(s):

One (1) at two hundred forty-nine (249) feet in length, and one (1) foot in width for a total of two hundred forty-nine (249) square feet. Existing sheeting is approximately thirty (30) feet in depth.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1140781 herein granted the sum of one

thousand two hundred (\$1,200.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
