BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT-4, Residential Two-Flat, Townhouse Jand Multi-Unit District symbols and indications as shown on Map No. 3-H in an area bound by

West Augusta Boulevard; a line 143.47 feet east of and parallel to North Hoyne Avenue; the public alley next south of and parallel to West Augusta Boulevard; And a line 119.80 feet east of and parallel to North Hoyne A venue

to those of a RM-4.5, Residential Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and due publication.


