ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the Ml-2, Limited Manufacturing/ Business Park District symbols and indications as shown on Map No. 11 -H in an area bound by

A line 241.6 feet north of and parallel to West Sunnyside Avenue; the public alley next east of and parallel to North Ravenswood Avenue; a line 142 feet north of and parallel to West Sunnyside Avenue; And North Ravenswood Avenue

to those of a C3-2, Commercial, Manufacturing and Employment District. SECTION 2. This ordinance takes effect after its passage and due publication.




