BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all BI-2 Neighborhood Shopping District symbols and indications as shown on Map No. 16-1 in the area bounded by

The alley next north of and parallel to West 69<sup>th</sup> Street (Lithuanian Plaza Court); a line 58.56 feet west of and parallel to South Rockwell Avenue; West 69<sup>th</sup> Street (Lithuanian Plaza Court); a line 83.56 feet west of and parallel to South Rockwell Avenue;

to those of a B2-2 Community Shopping District
