HE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO.

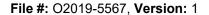
SECTION I. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance must be amended by changing all the RSI Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 8-G in the area bounded by:

West 31^{s1} Street; a line 23.12 feet west of and parallel lo South Morgan Street; the alley next south of and parallel to West 31^{s1} Street; a line 69.12 feet west of and parallel to South Morgan Street:

to those of a B2-2 Neighborhood Shopping District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

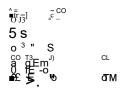
