ORDINANCE SILLIMAN GROUP, INC Acct. No. 340636 - 3 Permit

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to SILLIMAN GROUP, INC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, five (5) Landscaping(s) on the public right-of-way for beautification purposes adjacent to its premises known as 1525 E. Hyde Park Blvd..

Said Landscaping(s) at S. Harper Avenue measure(s):

One (1) at thirty-five point zero eight (35.08) feet in length, and nine point three five (9.35) feet in width for a total of three hundred twenty-eight (328) square feet.

Said Landscaping(s) at E. Hyde Park Blvd measure(s):

One (1) at seventy-five point seven five (75.75) feet in length, and fourteen point six seven (14.67) feet in width for a total of one thousand one hundred eleven point two five (1111.25) square feet.

One (1) at thirty-nine (39) feet in length, and fourteen point six seven (14.67) feet in width for a total of five hundred seventy-two point one three (572.13) square feet.

One (1) at fifty-one (51) feet in length, and fourteen point six seven (14.67<sup>^</sup>) feet in width for a total of seven hundred forty-eight point one seven (748.17) square feet.

One (1) at forty-one point five eight (41.58) feet in length, and ten point four two (10.42) feet in width for a total of four hundred thirty-three point two six (433.26) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed:inaccordance with plans and specifications approved by the Department of Planning and Development arid'Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1140872 herein granted the sum of zero (\$.00) per annum in advance.
