Be It Ordained by the City Council of the City of Chicago:

SECTION 1. PermissiCin and authority are hereby given and granted to U-HAUL CO. OF ILLINOIS, I'NC,, upon the terrris arid Subject' to the «^n^tti6Ti§;f!f"ihjs ofdiriahce to maintain and use two (2) sigh(s) projecting over the public "right-of-way attached to hs premises known as 235-259 E. 95th St.:

Said sign structure(s) measures as follows; along E. 95th:;

One (1) at eighteen point six (18.6) feet in length, 'three (3) feet in height and fifteen (15) feet above grade level.

One (1) at eight (8) feet in length, four point zero two (4.02) feet in height and fifteen (15) feet above grade level.

The Ideation of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1130612 herein granted the sum of six hundred (\$600.00) per annum in advance.

A 25%, penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in
