#### **ORDINANCE**

MetroPCS Authorized Dealer Acct. No. 392581 - 20 Permit No. 1140910<sup>s</sup>

#### Be It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to MetroPCS Authorized Dealer, upon the terms and subject to. the conditions of this ordinance to maintain and use three (3) sign(s) projecting over the public right-of-way attached to its premises known as 4559 S. Halsted St..

Said sign structure(s) measures as follows; along S. HALSTED STREET:

One (1) at nine (9) feet in length, one point four two (1.42) feet in height and nine point five (9.5) feet above grade level.

One (1) at thirteen (13) feet in length, two (2) feet in height and seventeen (17) feet above grade level.

One (1) at four (4) feet in length, seven (7) feet in height and eleven (11) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1140910 herein granted the sum of seven hundred (\$700.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
