### ***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the CI-1 Neighborhood Commercial District symbols and indications as shown on Map No.5-M in the area bounded by

The alley next north of and parallel to West Grand Avenue, a line 163.65 feet east of and parallel to North Parkside Avenue as measured at the north right-of-way line of West Grand Avenue; West Grand Avenue; and a line 85.83 feet east of and parallel to North Parkside Avenue as measured at the north right-of-way line of West Grand Avenue,

to those of a B2-2 Neighborhood Mixed-Use District and a corresponding uses district is hereby established

in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
