ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICA GO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B3-1 Community Shopping District symbols and indications as shown on Map No. 28-G in the area bounded by

West 115th Street; South Halsted Street; a line 200 feet south of and parallel to West 115th Street; and the alley next west of and parallel to South Halsted Street,

to those of a Cl-1 Neighborhood Commercial District and a corresponding use district is hereby established in the area above described.

SECTION2. This ordinance shall be in force and effect from and after its passage and due publication.


