TRAFFIC WARNING SIGN AND/OR SIGNALS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, of the Municipal Code of Chicago, that the Commissioner of Transportation is hereby authorized and directed to erect and/or amend Traffic Warning Signs and Signals, for the following locations are hereby designated:

WARD	TRAFFIC WARNING SIGNS AND/ORSIGNALS:
6	East 82nd Street and South Indiana Avenue; All Way Stop Sign, Stopping all approaches [02019-6655]
11	West 31st Street and South Normal Avenue; All-Way Stop Sign, Stopping All Approaches [Or2019-214]
13	South Menard Avenue and West 63rd Place; All Way Stop Sign, Stopping All Approaches - (19-01399560) [Or2019-192]
23	South Mason Avenue and West 57th Street; All Way Stop Sign, Stopping All 'Approaches - (19-01624685) [Or2019-298]
34	South Racine Avenue (west side) from West 103rd Street to West 107th Street; No Truck Parking Sign, All Times, All Days [02019-6775]
38	North Monitor Avenue and West Sunnyside Avenue; All-Way Stop Signs, Stopping All

Approaches - (19-01627475) [02019-6503] (Public Benefit)

- North Oak Park Avenue at West Albion Avenue; Two Way Stop Sign, Stopping North and South bound traffic on North Oak Park Avenue at Albion Avenue [Or2019-311]
- West Albion Avenue at North Normandy Avenue; Two Way Stop Sign, Stopping East and West bound traffic at North Normandy Avenue [Or2019-312]

SECTION 2. This ordinance shall take effect and be in force here in after its passage and publication.
