ORDINANCE

Mac Property Management Acct. No. 387132- 18 Permit No. 1140420

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to Mac Property Management, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use two (2) Landscape Fence(s) on the public right-of-way adjacent to its premises known as 5454 S. Shore Dr..

Said Landscape Fence(s) at S. Shore measure(s):

One (1) at one hundred six (106) feet in length, and point two five (.25) feet in width for a total of twenty-six point five (26.5) square feet Said landscape fence is approximately sixteen (2) feet in height.

One (1) at one hundred seventeen (117) feet in length, and point two five (.25) feet in width for a total of twenty-nine point two five (29.25) square feet Said landscape fence is approximately sixteen (2) feet in height.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago, as compensation for the privilege #1140420 herein granted the sum of zero (\$.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
