ORDINANCE  
KHALIL'S FOOD & LIQUOR Acct. No.  
16717-1 Permit No. 1141908

*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to KHALIL'S FOOD & LIQUOR, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, four (4) Fire Shutter(s) projecting over the public right-of-way adjacent to its premises known as 146 W. 103rd St..

Said Fire Shutter(s) at W 103rd Street measure(s):

One (1) at eleven point seven five (11.75) feet in length, and point eight three (.83) feet in width for a total of nine point seven five (9.75) square feet.

One (1) at twelve point five six (12.56) feet in length, and point six seven (.67) feet in width for a total of eight point four two (8.42) square feet.

One (1) at nine point seven five (9.75) feet in length, and point seven five (.75) feet in width for a total of seven point three one (7.31) square feet.

One (1) at eleven point five eight (11.58) feet in length, and point five eight (.58) feet in width for a total of six point seven two (6.72) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1141908 herein granted the sum of one thousand six hundred (\$1,600.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
