BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, Section 090, of the Municipal Code of, Chicago, portions of the below named streets are hereby designated as Residential Permit Parking Zones, for the following locations:

3	1900-1999 South Prairie Avenue, designated as a buffer zone for Residential Permit Parking Zone 1677 [02019-2820]
14	5200-5299 South Parkside Avenue (north and south sides) from West 52nd Street to West 53rd Street; Residential Permit Parking Zone, All Times, All Days [Or2019-288]
14	5000-5099 South Talman Avenue (east and west sides); Residential Permit Parking Zone, All Times, All Days [Or2019-289]
14	5515-5517 South St. Louis Avenue from West 55th Street to West 56th Street; Residential Permit Parking Zone 2198 [Or2019-383]
14	4431 West 57th Street (south side) from South Kenneth Avenue to the first alley east thereof; Residential Permit Parking Zone 345, All Times, All Days [Or2019-385]
