BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3, Residential Single Unit (Detached House) District symbols and indications as shown on Map No. 3-J in an area bound by

The public alley next north of and parallel to West Hirsch Street; North Saint Louis Avenue; West Hirsch Street; And a line 47.05 feet west of and parallel to North Saint Louis Avenue

to those of a RM-4.5, Residential Multi-Unit District.


SECTION 2. This ordinance takes effect after its passage and due publication.
