ORDINANCE Petco# 1989 Acct. No. 19916-19 Permit No. 1142301

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to Petco # 1989, upon the terms and subject to the conditions of this ordinance to maintain and use three (3) sign(s) projecting over the public right-of-way attached to its premises known as 611 W. Roosevelt Rd..

Said sign structure(s) measures as follows; along Roosevelt:

One (1) at twelve point zero eight (12.08) feet in length, two point four six (2.46) feet in height and fourteen (14) feet above grade level.

One (1) at ten (10) feet in length, four (4) feet in height and fourteen (14) feet above grade level. One (1) at twenty-six point six seven (26.67) feet in length, five point eight seven (5.87) feet in height and fourteen (14) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and-specifications approved by the Department of Transportation (Division of Project Development) and Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1142301 herein granted the sum of nine hundred (\$900.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
