Be It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to THE US STORE, upon the terms and subject to the conditions ofthis ordinance to maintain and use two (2) sign(s) projecting over the public right-of-way attached to its premises known as 116 W. Jackson Blvd..

Said sign structure(s) measures as follows; along W. Jackson Blvd:

One (1) at seven point four two (7.42) feet in length, two point five (2.5) feet in height and twelve point three three (12.33) feet above grade level.

Said sign structure(s) measures as follows; along W. Jackson Blvd:

One (1) at three (3) feet in length, three (3) feet in height and twelve point three three (12.33) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.
