A line 149.35 feet south of and parallel to west Altgeld Street; North Lorel Avenue; a line 179.35 feet south of and parallel to west Altgeld Street; and the alley west of and parallel to North Lorel Avenue

to those of a RT 3.5 Residential two-Flat, Townhouse and Multi-Unit District.
