A line 275 feet north of and parallel to West Barry Avenue; the public alley next east of and parallel to North Central Park Avenue; a line 250 feet north of and parallel to West Barry Avenue; And North Central Park Avenue to those of a RM-4.5, Residential Multi-Unit District.
