BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

SECTION 1: Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all the B3-2 Community Shopping District symbols and indications as shown on Map No. 9-G in an area bounded by:

a line 34.0 feet southeast of and parallel to West Eddy Street; North Clark Street; a line 84.07 feet southeast of and parallel to West Eddy Street; and the alley next southwest of and parallel to North Clark Street

to the designation of C2-2 Motor Vehicle-Related Commercial District and a corresponding use district is hereby established in the area above described.

SECTION 2: This Ordinance shall be in force and effect from after its passage.






