ORDINANCE LAKEVIEW SMILES Acct. No. 391838-2 Permit No. 1141968

Be It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to LAKEVIEW SMILES, upon the terms and subject to the conditions of this ordinance to maintain and use three (3) sign(s) projecting over the public right-of-way-attached to its premises known as 1977 N. Milwaukee Ave..

Said sign structure(s) measures as follows; along N MILWAUKEE AVE:

Two (2) at twenty-one point five (21.5) feet in length, one point five (1.5) feet in height and sixteen (16) feet above grade level.

One (1) at two point six seven (2.67) feet in length, two point six seven (2.67) feet in height and sixteen (16) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1141968 herein granted the sum of seven hundred (\$700.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
