SECTION 1. Permission and authority are hereby given and granted to ELITE TOTAL REHAB, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Awning(s) projecting over the public right-of-way adjacent to its premises known as 7008 W. Higgins Ave..

Said Awning(s) at W. Higgins Ave measure(s):

One (1) at twenty-four (24) feet in length, and two point three three (2.33) feet in width for a total of fifty-five point nine two (55.92) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

Be It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to CUSTOM EYES, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Awning(s) projecting over the public right-of-way adjacent to its premises known as 134 N. La Salle St..

Said Awning(s) at N. LA SALLE STREET measure(s):

One (1) at fourteen (14) feet in length, and one (1) foot in width for a total of fourteen (14) square feet.
