remembered for his commitment to improving law enforcement, fighting for racial justice, and advocating for diverse hiring practices of officers; and

WHEREAS, John J. Jemilo also served as Executive Director of the Chicago Crime Commission and taught as an adjunct law professor at Loyola University and DePaul University; and
